## 1. Introduction

The Board, vide B.O. (MF) No. 1099 (PS-I/Pension Revision/2011) dated 31-05-2012 has revised the rates of Pension and other related benefits to the Pensioners/family pensioners of the Board based on the Government Orders read as (6), (7) and [12] above.

The following instructions/guide lines are issued for revision of Pensionary benefits to the Pensioners/Family Pensioners of the Board in accordance with the provisions of the Board Order read as (1) above.

## 2. Date of Effect

The revision of Pension/Family pension and allied benefits will have effect from 1-7-2008/1-8-2008 for officers and workmen respectively, unless other wise specified in this circular. OROP benefit shall be effected from 1-4-2010 onwards.

## 3. Service Pension - Rate, Minimum and Ceiling

- 3-1 The present system of computation of pension at 50% of the average of last ten months pay in all cases subject to the satisfaction of conditions for earning full pension or part thereof will continue. The normal rate of Family Pension will continue as 30% of last pay.
- 3-2 For computing last ten months pay for the purpose of average emoluments for pension, in respect of Officers/Workmen who retired from service on or after 31-7-2008/31-8-2008 (as the case may be) and who, during part of the said period of 10 months, drew pay in the pre-revised scale, their pay in the pre-revised scale will be enhanced notionally by adding applicable DA on the pre-revised pay for each of the above said period of ten months. (as in the pension revision of 2003). If any drop in existing pension occurs, such drop shall be treated as personal allowance not to be absorbed in future increase in Dearness Relief.

## 3-3 <u>Minimum and Maximum of Ceiling of pension after pay revision/</u> Pension revision.

The minimum and maximum pension will be enhanced based on the revised pay/pension as follows:

# 5. REVISION OF PENSION / FAMILY PENSION IN RESPECT OF OFFICERS WHO RETIRED / EXPIRED WHILE IN SERVICE ON OR AFTER 1-7-2008 AND WORKMEN WHO RETIRED / EXPIRED WHILE IN SERVICE ON OR AFTER 1-8-2008

- 5-1 Pensionary benefits/family pension will be calculated with reference to the revised pay introduced with effect from 1-7-08/1-8-08 to (Officers/Workmen) as the case may be as per para 2.1 of the Board Order dated 31-05-2012.
- 5-2 Dearness Relief on the revised pension/family pension is admissible at the rate indicated in para 2.5 of the Board order dated 31-05-2012.
- 5-3 The Special pay sanctioned to various posts in lieu of higher time scale shall be counted for calculating pension.
- 5-4 The terminal leave surrender shall be calculated based on revised salary.
- Note:- 1. Protected amount as per clause 15 of the LT settlement dated 28-2-2011 will not be reckoned for computation of pension.

- 6. REVISION OF PENSION IN RESPECT OF OFFICERS WHO RETIRED/ EXPIRED PRIOR TO 1-7-2008 AND WORKMEN WHO RETIRED/ EXPIRED PRIOR TO 1-8-2008 (Para 3.2 (1) of the Board Order dated 31-05-2012)
- 6-1 Pension in respect of officers/workmen shall be revised with effect from 1-7-2008 and 1-8-2008 respectively as follows:
- (a) Add the following components to the Existing Basic pension as on 30-6-2008/31-7-2008 as the case may be
- (i) Fitment benefit of 12% of the existing basic pension. If it involves fraction of a rupee, it shall be rounded off to the next higher rupee.
- (ii) DR @ 45% of Existing Basic Pension as on 1-7-2008/1-8-2008 rounded off to the next higher rupee.
- (b) The total amount arrived at as per Para 6-1(a) will be the revised Basic pension as on 1-7-08/1-8-08, as the case may be
- 6.2 In the case of pensioners having Qualifying Service 30 years and above the consolidated pension arrived as per 6-1(a) above shall not be less than 50% of the minimum of the pay in the corresponding revised scale of the post from which the pensioner retired and if the pension so arrived is less than 50% such pension shall be stepped up to 50% of the minimum of the revised scale.
- 6-3 In the case of pensioner having qualifying service below 30 years, proportionate pension indicated in schedule I of B.O dated 31.5.2012 is admissible.
- 6-4 The fixation made as per 6.2 & 6.3 above will be admissible only from 01.04.2010.
- 6-5 If, in any case, the amount so arrived at is less than the revised minimum pension ie. Rs.4100/- it shall be stepped up to the level of the revised minimum pension with effect from 1-7-08/1-8-2008 (See Para 4.2(2) the B.O. dated 31-05-2012). If the pension so arrived as per clause 6-2 is greater than the pension arrived as per clause 6-1, the pension fixed as per clause 6-2 shall be the revised pension from 1.4.2010. (See para 3-2-7 of B.O dated 31.5.2012).

- Dearness relief on the revised pension is admissible at the rate indicated in para 4-3(1) of Board Order dated 31-05-2012.
- 6-7 Revised Pension as per para 6-1(b) above is not commutable (see para 3.2(1) of the B.O. dated 31-05-2012.
- 7. REVISION OF FAMILY PENSION IN RESPECT OF OFFICERS WHO RETIRED / EXPIRED WHILE IN SERVICE PRIOR TO 1-7-2008 AND WORKMEN WHO RETIRED/EXPIRED WHILE IN SERVICE PRIOR TO 1-8-2008 (Para 3.2(a) of the Board Order dated 31-05-2012).
- 7-1 Family Pension in respect of officers/workmen shall be revised with effect from 1-7-2008 and 1-8-2008 respectively, as follows:
- (a) Add the following components to the existing basic family Pension as on 30-6-2008/31-7-2008 as the case may be.
- (i) Fitment benefit of 12% of the existing basic family Pension as on 1-7-2008/1-8-2008. If it involves fraction of a rupee, it shall be rounded off to the next higher rupee.
- (ii) DR @ 45% of the existing basic family Pension as on 1-7-2008/1-8-2008 rounded off to the next higher rupee.
- (b) The total amount arrived at as per 7-1 above will be the revised family pension as on 1-7-2008/1-8-2008 as the case may be (see illustration). If the amount so arrived at is less than Rs.4100/-, the same shall be stepped up to Rs.4100/-.
- 7-2 In the case of normal family pension, if the total of clause 4.2.1.a to 4.2.1.c of the B.O dated 31.5.2012 is less than the family pension corresponding to the minimum of the corresponding revised scale of the post from which the pensioner retired/expired while in service, as indicated in Schedule II, it shall be stepped up to the corresponding amount in Schedule II subject to a minimum of Rs.4100/-. For determining the corresponding revised scale of the post from which the pensioner retired/expired while in service, the provisions of clause 3.2.8 of the B.O dated 31.5.2012 shall apply. Fixation made as per this clause shall be admissible only from 01.04.2010.

- 7-3 The minimum family pension shall be stepped upto Rs.4100/- from Rs.2400/- and the maximum shall be Rs.16593/-, with effect from 01-07-2008/1-8-2008 as the case may be, as per para 1.1. of the Board Order dated 31-5-2012.
- 7-4 Dearness relief on the revised pension is admissible at the rate indicated in para 4.3 (i) of Board Order dated 31-5-2012.
- 7-5 Higher rate of family pension will be calculated as per para 1.2 of the Board Order dated 31-5-2012.

## 8. Death Cum-Retirement Gratuity

8-1 Gratuity shall be paid as per para 5 of Board Order dated 31-5-2012.

- 8-2 The existing pension scheme as per KSR except payment of DCRG may be continued and gratuity may be paid as per the Payment of Gratuity Act, 1972 on condition that the DCRG as per KSR will not be claimed in lieu of the gratuity as per the Payment of Gratuity Act, 1972 at any point of time.
- 8.3 The service rendered in the Service of KSE Board alone be treated as Continuous service eligible for reckoning gratuity as per the Payment of Gratuity Act, 1972.
- 8.4 Calculation of gratuity as per Payment of Gratuity Act, 1972 is as follows: (Pay last drawn + DA) X  $\frac{15}{26}$  X continuous service

## 9. <u>Commutation of Pension and restoration of Commuted</u> Portion of Pension

- 9-1. The existing rate of 40% of the Basic pension for commutation of pension will be continued.
- 9-2. <u>No commutation will be allowed</u> based on the revised pension in the case of pensioners who have retired on or before 30-4-2012.
- 9-3. The existing rate of commutation of pension (40% of the B.P) shall be admissible on the revised pay (in the revised scale of pay implemented vide Board Order cited as (8) and (9) above) shall be applicable in the case of retirement on or after 1-5-2012 only.
- 9-4. The existing commutation factor and period of restoration shall be continued.
- 9-5 Commuted portion shall be restored after 12 years from the date of commutation, as it exists now in cases where commutation is done at retirement at the age of 55. In other cases, the turn for restoration will be determined with reference to the commutation factor (rounded) adopted in each case as at present.

## 10. Medical Allowance to pensioners and family pensioners.

Medical allowance now being paid to the pensioners/family pensioners at the rate of Rs.100/- per month will be continued.

#### 11. EX-GRATIA PENSIONERS

11-1 Ex-gratia pension is revised with effect from 1.7.2008/1.8.2008 as follows

## 12. Part Time Contingent Pensioners

## 12-1 Pension / Family Pension in respect of part time contingent employees who retired / expired prior to 1-8-2008 is revised with effect from 1-8-2008 as shown below

- (a) Add the following components to the Existing basic pension as on 31-7-08.
  - (i) Fitment benefit of 12% of the existing basic pension/family pension (Para 11.2 (b)) of B.O dated 31.5.2012. If it involves fraction of a rupee, it shall be rounded off to the next higher rupee.
  - (ii) DR @ 45% of the existing Basic pension/Family pension as on 31-7-08 as rounded off to the next higher rupee.
- (b) The total of the figures under para 12.1 will be the revised Pension/Family Pension as on 01-08-2008.
- 12-2 Revised maximum **pension** will be Rs.4538/- (Para 9 B.O dated 31.5.2012)
- 12-3 Revised minimum **Pension** will be Rs.2000/- (Para 9)
- 12-4 Revised maximum family pension will be Rs.2723/- (Para 9)
- 12-5 Revised minimum **Family pension** will be Rs.1300/- (Para 9).
- 12-6 DR will be paid at the rate shown in Para 4 -3 (1) of B.O dated 31.5.2012.

In the case of family pension, if the total of 12.1 (a) to (b) is less than 30% of the minimum of the new scale from which the pensioner retired/expired while in service, it shall be stepped up to 30% of the minimum of the respective new scales subject to the minimum as follows. (Para 12.4 of B.O dated 31.5.2012).

## 13. Revision of pension / family pension in respect of parttime contingent employees who retired on or after 1-8-2008

13-1 Pensionary/family pensionery benefit will be calculated with reference to the revised pay introduced with effect from 1-8-2008. The revised Basic Pension should be subject to the minimum as shown in Para 9 of the Board Order dated 31-5-2012.

2. D.R. Will be paid at the rate shown in Para 4-3 of the B.O. dated 31-5-2012.

## 14. Gratuity (PTC Pensioners)

PTC pensioners are eligible for gratuity under Act 1972 specified in para 5 of the B.O. dated 31-5-2012.

## 15. Mode of Payment of arrears

- 1. The arrears on account of Pension and other benefits shall be disbursed in three consecutive half yearly installments beginning from 5/2012.
- 2. Arrears in respect of pensioners who have completed 75 years of age as on 31-5-12 (the Date of Order) and in respect of family pensioners shall be disbursed in lump.
- 3. Arrears in respect of pensioners who retired on or after 24-05-1994 shall be disbursed only after verifying whether any amount drawn in excess by the pensioner in respect of gratuity as per Gratuity Act 1972 and getting concurrence from the Accounts Officer Pension- Sanction.

## 16. Authorization of Revised Pensionary claims

- 16-1 Revision of pension and pensionary benefits in respect of all pensioners who retired on or before 1-7-2008 / 1-8-2008 as the case may be (Service pensioners, family pensioners, PTC pensioners, PTC family pensioners, ex-gratia pensioners) shall be done at the ARUs concerned.
- 16-2 All pensioners shall submit application for revision of pension (appendix-II) to the concerned Heads of Account Rendering Units from where they are drawing pension/family pension.

### 17 General

- 1. Excess payment, if any, made on account of revision of pensionary benefits, Dearness Relief, payment made on account of gratuity as per the Payment of Gratuity Act, 1972 shall be recovered from the eligible arrears accrued as per this order and also arrears of future revision of Dearness Relief on pension without fail.
- 2. In the case of pension requiring revision on the basis of fixation of pay in the revised scale of pay, pay fixation statement, revised LPC, application for revision of pension (Appendix-II), declaration in form given in appendix-II etc may be forwarded to Accounts Officer (pension sanction), office of the Chief Engineer (HRM), Vydyuthi Bhavanam, Thiruvananthapuram along with Service Book for sanctioning the revised pension. Necessary authorization may be obtained from the Accounts Officer (Pension Authorization) office of the Chief Engineer (HRM) before effecting payment.
- 3. The software module for fixation & revision of pension 2008 of officers and staff is uploaded and available in hris.kseb.in.
